RESOLUTION NO. 2020-32

A RESOLUTION ESTABLISHING FUND 236 LABELED COVID CARES ACT FUND AND CORRESPONDING LINE ITEMS, APPROPRIATING REVENUE INTO THE NEWLY CREATED FUND FUND AND DECLARING AN EMERGENCY

WHEREAS THE Auditor desires to create the Covid Cares Act Fund and corresponding line items in that fund to deposit and track any monies received from that source.

WHEREAS the City will receive Covid Cares Act funds in the amount of \$111,333.68.

BE IT RESOLVED BY THE COUNCIL FOR THE CITY OF WELLSTON, STATE OF OHIO, as follows:

Section One: The City of Wellston Auditor is hereby authorized to establish and thereby it is hereby established the following Fund and line items:

- Fund 236 COVID CARES ACT FUND
- Line items 236-3000-437400 Grants
- 236-9000-499300 Other
- 236-6066-540331 Relief Fund Expenses
- 236-6066-590430 Incidentals

Section Two: The appropriation ordinance as it relates to the following funds is hereby modified so as to appropriate additional moneys as follows:



Section Three: This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, in that it is necessary to approve this additional appropriation in order that expenses can be timely paid as incurred and in accordance with the city's obligations. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

Section Four: In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.


