ORDINANCE NO. 2020-50

**AN ORDINANCE BY THE COUNCIL OF THE CITY OF WELLSTON, OHIO TO PURCHASE ONE (1) FORD F250 TRUCK THROUGH COOPERATIVE PURCHASING FOR AN AMOUNT NOT TO EXCEED THIRTY-EIGHT THOUSAND (\$38,000.00), AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City of Wellston, Ohio has determined and identified the immediate need for a new Ford F250 Truck for the Street Department of the City of Wellston,

**WHEREAS**, the City of Wellston has located the same through a Cooperative Purchasing Consortium;

**WHEREAS**, the City of Wellston has the funds available in the Sales Tax Improvement Fund for the purchase of the Ford F250 truck;

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WELLSTON, OHIO, AS FOLLOWS:**


**Section One:** The Mayor and/or Safety/ Service Director of the City of Wellston, Ohio are hereby authorized to enter into a purchase agreement to purchase One(1) New Ford F250 truck through Cooperative Purchasing for an amount not to exceed \$38,000.00.

**Section Two:** This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.


**Section Three:** In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, the this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

**Section Four:** It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
