ORDINANCE NO. 2020-05

**AN ORDINANCE ESTABLISHING ADVANCE IN AND ADVANCE OUT LINE ITEMS IN THE FIRE FUND AND APPROVING THE ADVANCE OF \$125,000 FROM THE GENERAL TO THE fire fund AND DECLARING AN EMERGENCY**

WHEREAS THE Auditor desires to advance \$125,000.00 from the General Fund to the Fire Fund to provide funding to the fire department until property tax revenue is received. The monies advanced will be returned upon receipt of said property tax revenues.

WHEREAS the Auditor for the City of Wellston desires to create "Advance In" and "Advance Out" line items in the Fire Fund Budget to facilitate the advance of monies.

BE IT ORDAINED BY THE COUNCIL FOR THE CITY OF WELLSTON, STATE OF OHIO, as follows:

**Section One:** The City of Wellston Auditor is hereby authorized to establish and thereby it is hereby established "Advance In" 201-4000-499200 and "Advance Out" 201-1020-599100 line items in the General Fund Budget.

**Section Two:** The City of Wellston Auditor is hereby authorized to transfer \$125,000.00 from the General Fund to the Fire Fund to cover Fire Department expenses until the receipt of property tax revenues. Monies advanced will be returned upon receipt of said property tax revenues

**Section Three:** This Ordinance is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, in that it is necessary to approve this additional appropriation in order that expenses can be timely paid as incurred and in accordance with the city's obligations. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

**Section Four:** In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

**Section Five:** It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
