ORDINANCE NO. 2021-34

**AN ORDINANCE BY THE CITY OF WELLSTON LEGISLATIVE AUTHORITY
AUTHORIZING THE CORRECTION OF RELEVANT SECTIONS OF CHAPTER 51
OF THE WELLSTON CODE AND DECLARING AN EMERGENCY**

WHEREAS the City of Wellston Council has established rules and regulations for municipal Water and Sewer Charges and have codified those Rules as Chapter 51 of the Wellston Codified Ordinances: Water and Sewer Rates, specifically Section 51.08 titled Water and Sewer Rate Schedule of the Wellston Codified Ordinances, adopting a table with water and sewer rates; and

WHEREAS, due to a small mathematical error a nominal correction needs made that will not substantially affect any utility customer; and

WHEREAS the Council has determined that it is in best interest of the health safety and welfare of the inhabitants of the City to adopt the Rules,

NOW THEREFORE BE IT ORDAINED by the Council that:

Section One: The City Auditor and/or Clerk may make a necessary correction to the published rate table found in Chapter 51: Water and Sewer Rates specifically being Section 51.08 titled Water and Sewer Rate Schedule of the Wellston Codified Ordinances so as to conform with rates approved by the City Planning Committee and the table developed to corrections is hereby adopted and is to be published as the official water and sewer rate table for the City of Wellston.

Section Two. This Ordinance is hereby declared an emergency measure pursuant to Ohio Revised Code Section 731.30 and its immediate passage is necessary in order to preserve, protect and maintain the health, safety and welfare of the citizens of the City or Wellston, Ohio and as such shall take effect and be in full force immediately upon its passage and approval.

Section Three. In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

Section Four. It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
