

RESOLUTION NO. 2021-35

A RESOLUTION BY THE COUNCIL OF THE CITY OF WELLSTON, OHIO AUTHORIZING THE MAYOR AND OR SERVICE DIRECTOR TO ENTER INTO A CONTRACT WITH SUNRUSH WATER FOR THE SALE OF WATER AND ESTABLISHING RATES AND DECLARING AN EMERGENCY.

WHEREAS, the City of Wellston, Ohio desires to enter into an agreement to sell City water to Sunrush Water owned by Michael Blum, and;

WHEREAS, the prior Service Director for the City of Wellston, Ohio negotiated a tentative agreement involving rates; and

WHEREAS, the rate terms of the tentative agreement are hereby attached for reference, and;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WELLSTON, OHIO, WITH TWO THIRDS OF MEMBERS IN CONCURRENCE, AS FOLLOWS:

SECTION 1. The Mayor and/or the Service Director of the City of Wellston, Ohio are hereby authorized to enter into a contract with Sunrush Water and owner Michael Blum for the sale of City Water at a rate consistent with the attached agreed upon proposal.

SECTION 2: This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, in that it is necessary to approve this additional appropriation in order that expenses can be timely paid as incurred and in accordance with the city's obligations. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

SECTION 3: In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

SECTION 4. It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of this council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
