RESOLUTION NO. 2021-61

AN RESOLUTION AUTHORIZING REGULAR BLANKET CERTIFICATES FOR THE YEAR 2022, SETTING EXPIRATION DATES FOR REGULAR CERTIFICATES AND DECLARING AN EMERGENCY

Whereas, the City Auditor may be authorized to issue regular blanket certificates with an expiration date no later than December 31st of the year for which said regular blanket certificates are issued and in an amount not to exceed One Hundred Thousand Dollars (\$100,000.00); and

Whereas, the City of Wellston can establish an expiration date for regular blanket certificates; and

Whereas, the Council for the City of Wellston has determined it appropriate and desires to authorize the Auditor to issue blanket certificates for the year 2022 and set an expiration date for those regular blanket certificates,

BE IT ORDAINED BY THE COUNCIL FOR THE CITY OF WELLSTON, STATE OF OHIO, as follows:

Section One. The Auditor for the City of Wellston is hereby authorized to issue regular blanket certificates for the year 2022 with an expiration date no later than December 31st of the year for which said regular blanket certificates are issued, being 2022, and in an amount not to exceed One Hundred Thousand Dollars (\$100,000.00).

Section Two. This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, in that it is necessary to approve this resolution in order that current expenses can be timely paid as incurred and in accordance with the city's obligations. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

Section Four: In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

Section Five: It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
