RESOLUTION NO. 2021-21

AN RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF WELLSTON TO CONSENT TO CONTRACTS WITH STANTEC CONSULTING SERVICES INC. TO PROVIDE GENERAL ENGINEERING SERVICES TO THE CITY TO BE ASSIGNED TO DLZ OHIO. INC. AND DECLARING AN EMERGENCY

WHEREAS, the City of Wellston previously entered into a contract with Stantec Consulting Services, Inc., for the provision of general engineering services to the City, and

WHEREAS, Stantec is currently providing Engineering Services on multiple City projects, and

WHEREAS, Stantec has been purchased by DLZ OHIO Inc, and

WHEREAS, the City of Wellston desires to provide for the continuity of those services so that the current projects are not interrupted or delayed, and

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL FOR THE CITY OF WELLSTON, STATE OF OHIO, as follows:

Section One: The Mayor of the City of Wellston be and is here by authorized to sign or execute any and all documents necessary to consent to the assignment of contracts currently entered into with Stantec Consulting Services Inc. to it successor DLZ Ohio Inc.

Section Two: This Resolution is hereby declared to be an emergency, necessary for the immediate preservation of the public peace, health or safety of the City of Wellston, in that it is necessary to approve this additional appropriation in order that expenses can be timely paid as incurred and in accordance with the city's obligations. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor, as provided in the Ohio Revised Code Section 731.30.

Section Three: In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

Section Four: It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
