RESOLUTION NO. 2022-30

A RESOLUTION SUPPORTING THE OHIO VALLEY REGIONAL DEVELOPMENT COMMISSION'S 2022 APPALACHIAN REGIONAL COMMISSION'S POWER INITIATIVE GRANT APPLICATION

WHEREAS, the City of Wellston, Ohio supports the Ohio Valley Regional Development Commission's 2022 Appalachian Regional Commission's Power Initiative Grant Application and;

WHEREAS, the Appalachian Regional Commission offers POWER Technical Assistance Grants that assist regions with up to \$50,000 to determine the feasibility of potential projects; and

WHEREAS, the Ohio Valley Regional Development Corporation's Executive Committee adopted Resolution 22-03-02 authorizing the submission of a grant application to examine the feasibility of constructing a multi-use path from Lake Hope to Jackson Lake State Park, and;

WHEREAS, Communities across Southern Ohio recognize that outdoor recreation supports health, contributes to a high quality of life, and attracts and sustains employers and families; and

WHEREAS, the outdoor industry in Southern Ohio can be a major economic engine that brings jobs, prosperity, and wellness to the region's residents; and

WHEREAS, investments in outdoor spaces and amenities will serve to enhance the quality of outdoor experiences for all Ohioans.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WELLSTON, OHIO, AS FOLLOWS:

SECTION 1. This Resolution expresses the support the City of Wellston's support of the Ohio Valley Regional Development Commission's 2022 POWER Technical Assistance grant application, funding a feasibility study of the "Connecting Ohi Valley Parks Multi-Use Trail Project" through Jackson and Vinton Counties.

SECTION 2: It is hereby found and determined that all formal acts of this Council concerning and relating to adoption of this Resolution were adopted in an open meeting of this Council and deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
