RESOLUTION NO. 2022-55

**A RESOLUTION BY THE LEGISLATIVE AUTHORITY FOR THE CITY OF WELLSTON AUTHORIZING THE SALE, BY INTERNET AUCTION DURING CALENDAR YEAR 2023, OF CITY OWNED PERSONAL PROPERTY WHICH IS NOT NEEDED FOR PUBLIC USE OR WHICH IS OBSOLETE OR UNFIT FOR THE USE FOR WHICH IT WAS ACQUIRED**

**WHEREAS**, pursuant to R.C. 721.15(D), Council for the City of Wellston, Ohio may adopt, during each calendar year, a resolution expressing its intent to sell municipally owned property, regardless of the property's value, by internet auction. This resolution must include a description of how auctions will be conducted, specifying the number of days for bidding, and stating the general terms and conditions of sale; and

**WHEREAS**, the City will benefit from receiving income into the City derived from the sale of surplus property; and

**WHEREAS**, where staff determines internet auction is the most cost effective and efficient means of disposing of said property, the public is hereby given notice that the general terms and conditions established below will be utilized when conducting the internet auction process on GovDeals or any similar on-line auction service.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WELLSTON, STATE OF OHIO, THAT:**

**SECTION 1:** During calendar year 2023, city owned personal property that is not needed for public use, or which is obsolete or unfit for the use for which it was acquired, may be sold at internet auction.

**SECTION 2:** All internet auction sales shall be conducted under the authority and direction of the Safety-Service Director or his designee(s), who shall set a minimum bid for all property sold by internet auction as well.

**SECTION 3:** All internet auction sales shall be conducted by GovDeals.com internet auction service, or a similar web site.


**SECTION 4:** All internet auction sales shall be conducted pursuant to the rules and regulations promulgated and in effect for the internet auction site. For each internet auction sale, bidding shall remain open for not less than ten (10) days, including Saturdays, Sundays and legal holidays.

**SECTION 5:** All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.

**SECTION 6:** It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and the deliberations of the council and any of its committees that resulted in such formal

action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
